Hi Dave,

My name is Joannie Belanger, and along with my partner Catherine Chevalier (Captain with NEMI Fire), we purchased a 50-acre bush lot from our neighbor, Dean Lockyear, a couple of years ago. Dean mentioned that I should reach out to you directly regarding this matter—if there's a more appropriate channel to go through, please don't hesitate to let me know and I'll be happy to oblige.

Our property, located at **Bidwell Con 12 W 1/2 Lot 16**, is currently accessed from the north side via Limekiln Road, turning onto 20th Side Road, and then left onto the trail commonly referred to as the **Townline** trail. From what we understand, this trail is owned by the municipality.

At present, approximately two-thirds of the trail is cleared and passable. We are seeking **permission to clear** an additional 100–200 meters of brush and some trees in order to allow vehicle access to the entrance of our lot—primarily to bring a truck onto the property. This would significantly improve access and allow us to begin modest improvements and maintenance on our land.

We intend to approach this work responsibly and with minimal disruption to the surrounding environment. If there are specific guidelines, permits, or oversight required, we are more than willing to comply.
