Two deck permits, three new residential dwelling permits, one new seasonal dwelling permit, four detached garage permits, two residential reno/addition permits, one commercial renovation permit, one demolition permit and one accessory building permit have been issued since the last report. This report period has a construction value of \$3,148,000.00 and a permit value of \$38,377.00. The total value of construction value to date is \$5,200,000.00 with a total building permit revenue of \$57,436.00.

This letter is regarding the use of outdoor fire pits.

It is my understanding the by-law for having a fire within the Town limits it should be in a chimney type container.

Well most of council knows that I love to walk and do a lot of my walking in the evening now that the warm weather has arrived.

On these evening walks I am alarmed at the number of homeowners or renters that do not have this type of fire pit for their fires. I have witnessed large fires in open pits in back yards with sparks flying high in the air. In one case last year I was concerned for the neighbor of the party having the fire as should these sparks light on a car or tarp the whole block could have been wiped out.

I would like to recommend to Council that they advertise the by-law now at the beginning of summer. Yes, social media is fine, but possibly a flyer in the mail or put a notice in tax bills, water bills as we have so many new people moving to town plus we have several Air B&B's that the owners are from out of Town and possibly unaware of the by-law.

Possibly the Fire Department could hand out flyers to home owners about the bylaw or do an inspection, this might help solve the problem before we have a fire in a neighborhood.

I know I am not the only party concerned about this but having to sign a letter of complaint does not make for a friendly neighborhood.

So I am writing this letter to give Mayor and Council heads up on this problem without naming anyone in particular.
