Dear Mr. MacNevin and Mr. Williamson,

Thank you for attending my 20 minute presentation at the MMA. I am delighted to do a 10 minute version for NEMI on June 5.

Congratulations on Manitoulin Island being one of the Top 10 on CBC's <u>Oh Canada! Destination Bucket List</u>. This reaffirms Manitoulin Island as a genuine treasure. It presents a wonderful opportunity for controlled tourism growth, as well as being a source of pride for your community.

I would like to discuss a project that could put this at risk: the project to *designate all of Georgian Bay, including Manitoulin Island, as part of a Georgian Bay UNESCO Geopark*. While the initial impression of a UNESCO designation seems favourable, the geopark is not being executed in a manner consistent with UNESCO's mandate nor in the spirit of Manitoulin Island's best interests.

As the largest freshwater island in the world and home to the largest lake on an island in the world, and as one of Canada's top 10 destinations, Manitoulin Island is an ideal candidate to be a **stand-alone UNESCO Global Geopark**. While at present time you may not wish to pursue this type of designation, if the Georgian Bay Geopark proceeds, Manitoulin Island will be permanently denied this opportunity.

My background is that I am an Adjunct Professor of Strategy and Marketing at Schulich School of Business, York University. I have also worked as a consultant with Economic Development departments. I am a retired board member of the charity Georgian Bay Forever and lifelong lover of Georgian Bay. I know Manitoulin Island well: I have chartered trawlers from CYC out of Gore Bay over five different years, as well as having taken our own boat to the North Channel multiple times. My unique combination of marketing expertise, economic development and extensive knowledge of Georgian Bay has armed me with the ability to understand the true intentions of the geopark – which is essentially to leverage Georgian Bay "assets" for the benefit of one county to the south.

Using this experience, I would like to provide a comprehensive overview of the Georgian Bay Aspiring Geopark – its history, its leadership and its intentions. Here is why you should be concerned:

The geopark is not a Georgian Bay initiative; it is a <u>Simcoe County initiative</u> dominated by people from southern Ontario attempting to "claim" all of Georgian Bay. Tony Pigott, geopark executive director and retired Toronto advertising executive, was initially hired by the Midland Bay Landing Development Corporation to undertake a feasibility study to designate Georgian Bay as a UNESCO Geopark in order to attract developers to build a UNESCO discovery centre in Midland. On September 15, 2021, in a deputation to Midland Council, Mr. Pigott presented that it was a <u>viable and valuable opportunity</u>. Below is a question posed by a member of Midland Council, Jon Main. Tony Pigott's response clearly illustrates that North Simcoe is the top priority for this project, not Manitoulin Island.

Jon Main – "If Midland is claiming, or initiating the Georgian Bay Geopark, Georgian Bay is quite large, and it goes over Collingwood, Parry Sound, Owen Sound, Killarney, Manitoulin Island, how would those municipalities come into play or collaborate or partner with this opportunity?"



Tony Pigott – "In time, other areas of Georgian Bay will engage, but <u>North Simcoe has the opportunity to be the</u> first mover, and to be the dominant (I won't say dominant) the gateway to the UNESCO Geopark and the place that people go to first, being adjacent as you are to four million people."

On May 3, 2021, in a second presentation to Midland Council, also on our website, Tony Pigott stated "<u>We believe</u>, as we did back in September of 2021 that Midland North Simcoe area is a genuine portal to deep time and a microcosm of the entire Georgian Bay Geopark."

Outside of being a source of funding, it is implausible that at 559 square kilometers, North Simcoe can act as a microcosm of all 48,000 square kilometers that are being claimed, let alone of Manitoulin Island.

The Aspiring Georgian Bay Geopark has identified eight "Deep Time" zones. Right now, they are branding Manitoulin Island as "Deep Time Zone 4: Tropical Seas". There are 5 destinations highlighted for Manitoulin Island - those are listed at the bottom of this letter.

As one of eight zones, and very far away from "the launching point", if this project proceeds Manitoulin Island will be lost in the clutter of destinations to the south. The following example illustrates that is already happening.

The first Georgian Bay Geopark tourism product, a <u>cycling tour</u> is scheduled for September 2025. The tour takes place at the southernmost tip of Georgian Bay, and some of it along Lake Huron. Even though the tour gets to Tobermory, guests do not cross over to Manitoulin Island. They actually spend 2 nights on the shores of Lake Huron and 2 nights near Lake Simcoe. Manitoulin Island is not a priority.

This letter lays out only a small portion of the concerns. I advise that it is in Manitoulin Island's best interests to get ahead of this initiative. To secure UNESCO recognition, the Geopark requires letters of support from all stakeholders, which would include every municipality and every First Nations community on Manitoulin Island. However, they are not waiting for UNESCO recognition to market Georgian Bay and they are already branding Manitoulin Island. A letter to the <u>Canadian Geopark Network</u> expressing concern or opposition would help to have the Aspiring Geopark status revoked, which would remove this threat and open the doors to a future opportunity for Manitoulin Island.

I would like the opportunity to present a delegation to council to provide you with further information and to discuss how this project is not optimal for Manitoulin Island. I am also happy to meet with you or with staff.



## BY-LAW NO. 2025-17

# BEING A BY-LAW TO PROVIDE FOR THE ADOPTION OF TAX RATES AND FURTHER PROVIDE FOR PENALTY AND INTEREST IN DEFAULT OF PAYMENT THEREOF FOR 2025

WHEREAS the Municipal Act, Chapter 25, S.O. 2001 provides that the Council of a local municipality shall after the adoption of estimates for the year, pass a by-law to levy a separate tax rate on the assessment in each property class, and

WHEREAS Section 307 of the said Act requires tax rates to be estimated in the same proportion to tax ratios, and

WHEREAS certain education rates are provided in various regulations, and commercial and industrial education amounts have been requisitioned by the Province,

NOW THEREFORE the Council of the Corporation of the Town of Northeastern Manitoulin and the Islands ENACTS AS FOLLOWS:

- 1. THAT the 2025 Operating and Capital Budgets be approved as Schedule "A" attached to and forming part of this by-law.
- 2. THAT the tax rates and ratios for 2025 for municipal and education purposes be hereby set as follows:

3. THAT all taxes shall become due and payable as follows:

For Residential, Pipelines, Farmland and Managed Forest Tax Classes, 50% of the final levy shall become due and payable on the 31<sup>st</sup> of July 2025 and the balance shall become due and payable on the 29<sup>th</sup> of September, 2025.

For Multi-Residential, Commercial, and Industrial Tax Classes, 50% of the final levy shall become due and payable on the 31<sup>st</sup> of July, 2025 and the balance shall become due and payable on the 29<sup>th</sup> of September, 2025.

- 4. Non payment of the amount, as noted, on the date stated in accordance with this by-law constitutes default. On all taxes of the levy which are in default after the noted due dates shall be added a penalty of 1-1/4% per month, until December 31, 2025.
- 5. On all taxes unpaid as of December 31, 2025 interest shall be added at the rate of 1-1/4% per month, for each month or fraction thereof in which the arrears continue.
- 6. All taxes are due and payable to the Town of Northeastern Manitoulin and the Islands, at the Town's municipal office.

Please be advised that during the regular Council meeting of May 27, 2025 the following resolution regarding Bill 5: Protecting Ontario by Unleashing Our Economy Act, 2025 was carried.

RESOLUTION NO. 205-317

DATE: May 27, 2025

MOVED BY: Councillor MacNaughton

SECONDED BY: Councillor Hirsch

WHEREAS the Government of Ontario has introduced Bill 5: Protecting Ontario by Unleashing Our Economy Act, 2025, which proposes substantial changes to many Acts within one bill which undermine environmental protections in order to "unleash the economy"; and

WHEREAS multiple inclusions will impact habitat, biodiversity protections and environmental integrity without proper process including but not limited to:

- the repeal and replacement of the Endangered Species Act with a weaker act;
- the creation of a Special Economic Zones Act which will permit exemptions from legislated environmental protections;
- changes to provisions to the Mining Act which provide sweeping powers to the Minister of Energy and Mines that are poorly defined, subject to caprice, or possibly designed to enable exemption from environment protection; and

WHEREAS proposed changes will override local planning authority, provincial legislation, and bylaw enforcement for the benefit of specific preferred proponents over the rights of Ontarians; and

WHEREAS First Nations citizens have an enshrined right to access their own archeology and Canadians have an enshrined responsibility to seek free, prior and informed consent from First Nation neighbours regarding land use; and

WHEREAS several proposed changes could imperil the health of lands and water for which First Nations have traditional and treaty rights; and

WHEREAS the provisions of the Special Economic Zones Act are not clear enough to ensure that there are adequate legal and environmental protections to offset risks to Ontarians and First Nations members, to provide adequate safeguards against bad faith environmental practice; and protect against unsafe labour practice as identified by labour sector organizations; and

WHEREAS fairness is enshrined in both Canada's and Ontario's laws yet proposed changes seem to permit prejudicial regulatory practice (e.g. codifying permissions for "trusted proponents" over others); and

WHEREAS the wording of the changes to the Electricity Act seem to support Canadian ownership of energy suppliers but appear to potentially restrict development of specific types of energy and could impact local renewable energy development; and

WHEREAS there is no evidence that undermining of environmental protections, local legal frameworks, and the rights of First Nations communities in Ontario are a necessary step to "unleash the economy"; and

NOW THEREFORE BE IT RESOLVED THAT the Council of the County of Prince Edward supports any regulation that could encourage energy providers to Buy Canadian but urges the province to clarify the proposed provisions of the Energy Act and ensure they foster local green energy development; and

THAT the province remove the elements in Bill 5 that would reduce current environmental protections, reduce protections for species at risk, and reduce legal protection from bad faith actors in special economic zones; and

THAT the Council of the County of Prince Edward urges the Province to further define Special Economic Zones and their purpose with more clarity and ensure that activities within such zones are equally subject to the local and provincial laws that support all of Ontario and First Nations people and foster our social, cultural and environmental prosperity;

AND FURTHERMORE BE IT RESOLVED THAT the Council of the County of Prince Edward expresses solidarity with the concerns of our neighbouring community, Mohawks of the Bay of Quinte and members of the Haudenosaunee Nation and support Mohawks of the Bay of Quinte and their letter to the province of May 16th 2025, attached; and THAT this resolution be shared with the Honourable Doug Ford, Premiere of Ontario; Stephen Lecce, Minister of Energy and Mines; Rob Flack, Minister of Municipal Affairs and

Good afternoon Mayor MacNevin,

Thank you for speaking with me last week regarding vegetation maintenance work our forestry crews are completing to ensure the safe and reliable delivery of electricity. I wanted to share an update and confirm that we have followed up with residents who reached out regarding this work.

Our highly-skilled and trained arborists identify vegetation that will pose a hazard to the transmission system and use a variety of techniques, including the selective application of herbicide, to complete required vegetation maintenance. Herbicide will be selectively applied on certain sections of the transmission corridor starting on Goat Island where a Hydro One station is located towards the Town of Espanola as well as within our stations on Manitoulin Island.

As part of our maintenance practices, crews seek permission from property owners prior to applying herbicides. When utilized, herbicides are also applied by our forestry professionals who are properly licensed, certified, and supervised in accordance with provincial rules, regulations, internal standards, and pesticide-specific applications.

An ad was placed in the local newspaper about the upcoming vegetation maintenance work, which listed NEMI as Goat Island is located within your community although not on the main Island. While herbicides will be selectively applied at our stations on Manitoulin Island and on our transmission corridor towards the Town of Espanola, we can confirm that Garlon and other herbicides will not be used on Manitoulin Island power line rights-of-ways. This is inclusive of all First Nation communities and municipalities.

We sincerely apologize for any inconvenience this may have caused. Please let me know if you have any questions.
